Admission Arrangements for Nursery (K1) Classes for the 2021/22 School Year

1. Collection of Application Forms (No quota):

- Download from the school website

- Obtain from school in person

2. Arrangements for Distribution of Application Forms:

- Distribution period: 22nd September 2020 (Tuesday)* to 28th October 2020 (Wednesday) * the second week of school

- Time: Mondays to Fridays (9:00 a.m. to 5:00 p.m.)
Saturdays (9:00 a.m. to 12:00 p.m.)

3. Application Form Submission (No Quota):

- Submission method: Please submit the application form to our school in person

- Required Documents:

1. A copy of the child's birth certificate / HKSAR Re-entry Permit / passport
 2. A copy of the child's double-sided immunisation record
 3. A photo of the child
 4. 4 stamped self-addressed envelopes (Please ensure each envelope bears sufficient postage with the return address and the Chinese name of the child written on it)
- Submission period: 22nd September 2020 (Tuesday)* to 28th October 2020 (Wednesday)

* the second week of school

- Time: Mondays to Fridays (9:00 a.m. to 5:00 p.m.)
Saturdays (9:00 a.m. to 12:00 p.m.)

4. Application Fee: HK\$40

5. Application for "2021/2022 Registration Certificate for Kindergarten Admission"

➤ Parents are required to apply to EDB for a "Registration Certificate for KG admission" (hereafter referred to as "RC") from September to November 2020. The "RC" will be open for applications in September 2020 and EDB will announce and upload the details of application onto EDB's website (www.edb.gov.hk) in due course. Upon receipt of the applications with all necessary information and documents provided, EDB will generally take six to eight weeks to complete processing of the applications and issue the "RC" to applicants who are eligible for receiving subsidy under the Scheme by post. A child may be eligible for receiving education in Hong Kong but may not be eligible for receiving subsidy under the Scheme, he/she would not receive a "RC". EDB will then issue a "Kindergarten Admission Pass" (hereafter referred to as "AP") to the student concerned for registration and admission to a Scheme-kindergarten but the parents concerned are required to pay full school fees before deduction of subsidy under the Scheme as shown on the Fees Certificate of the kindergarten to which the child is admitted.

6. Admission Criteria:

1. Applicants with sibling(s) currently studying in or graduated from our school will be given priority consideration
2. Applicants who live near the school district will be given priority consideration
3. Applicants from a dual-career family will be given priority consideration when applying for whole day classes
4. Parents who understand our school vision and teaching methods
5. The applicant's interview performance will be taken into consideration

7. Interview Arrangements:

- Interview Opportunities

All K.1 applicants will be given an interview slip with the interview date and time printed on it

- Interview Date

Date of 1st Round Interview: 7th November 2020 (Saturday)

- Interview Format

Parents should accompany their child for the interview

Play & Conversation --- Individual/Group

- Arrangements for Non-Chinese Speaking Applicants

English interpretation service will be arranged for children in need during the interview

8. Announcement of Admission Results and Arrangements:

- We will inform all parents of the admission results by post before 18th December 2020.

9. Registration Arrangements:

➤ Successful applicants:

Parents should complete the registration procedures for their child from 7th to 9th January 2021 (“Centralised Registration Dates”) by submitting the original of the “RC”/ “AP” to our school and paying the registration fee.

➤ Applicants on the waiting list:

If the successful applicant fails to register during the “Centralised Registration Dates”, we may allocate the unfilled places to applicants on the waiting list. Parents are required to complete the registration procedures by submitting the original of the “RC” / “AP” to our school and paying the registration fee within the specified dates.

➤ Unsuccessful applicants

Parents may obtain K1 vacancy information via EDB’s website, Regional Education Offices and EDB hotline (from late Jan 2021 onwards).

➤ Points to note

Please be reminded that if parents cannot submit the “RC” during the registration period, we may not be able to complete the registration for their child. Hence, parents are required to submit the application for the “RC” to EDB within the specified period.

The registration fee for 2021/22 half-day classes is HK\$970 and for the whole-day classes is HK\$1,570. The registration fee will be refunded to enrolled students in September.

Should parents decide to change their child’s school after registration, please notify us in writing. We will return the “RC” but the registration fee will not be refunded. Upon obtaining the “RC”, we will no longer keep the school place for the child.
